The LaGrange County Commissioners met in Regular Session on Monday, October 3, 2022, in their meeting room, County Office Building, 114 W. Michigan Street, LaGrange, Indiana, 46761, at 8:30 a.m., with the following present: Commissioners, Mr. Terry A. Martin, Mr. Kevin R. Myers, and Mr. Peter A. Cook; and LaGrange County Chief Deputy Auditor, Kay Myers. Mr. Terry Martin, President, called the meeting to order and led in saying the Pledge of Allegiance to the Flag. Mr. Kevin Myers made a motion to adopt the proposed agenda with flexibility. Mr. Peter Cook seconded the motion and it carried unanimously.

# PROBLEM-SOLVING COURT COORDINATOR - INDEPENDENT CONTRACTOR AGREEMENT

Mr. Kurt Bachman, County Attorney, presented an Independent Contractor Agreement for a Problem-Solving Court Coordinator. The agreement is between LaGrange County and Ernsberger and Helmer, Attorneys at Law, PC, by and through its attorney, Lisa L. Hanna, and shall be effective October 1, 2022 and the contractor would be paid \$5,381.25 per month. Mr. Peter Cook made a motion to approve the agreement and authorize the president to sign it. Mr. Kevin Myers seconded the motion and it carried unanimously.

### PARK - DELT CHURCH PARK PAVILION

Mrs. Mary Franke, Park Director, explained that on September 22, 2022 the Park Board opened bids for the Delt Church Park Pavilion. The lowest bid was from Shetler Construction in the amount of \$341,847.00, which is more than was budgeted. She is requesting an additional \$100,000 of American Recovery Plan Act (ARPA) funds for the Delt Church Pavilion. Mr. Kevin Myers made a motion to grant a positive recommendation to the County Council for the funding. Mr. Peter Cook seconded the motion and it carried unanimously.

# ENGINEER - REQUEST TO INSTALL MANHOLE

Mrs. Tharon Morgan, County Engineer, presented a quote Greg Owens in the amount of \$13,350, to furnish and install one complete 4' manhole near County Road 500 East and 250 North. Mr. Peter Cook made a motion to approve. Mr. Kevin Myers seconded the motion and it carried unanimously.
