REGULAR SESSION

The LaGrange County Commissioners met in Regular Session on Monday, December 19, 2022, in their meeting room, County Office Building, 114 W. Michigan Street, LaGrange, Indiana, 46761, at 8:30 a.m., with the following present: Commissioners, Mr. Terry A. Martin, Mr. Kevin R. Myers, and Mr. Peter A. Cook, and LaGrange County Auditor, Kathryn Hopper. Mr. Terry Martin, President, called the meeting to order and led in saying the Pledge of Allegiance to the Flag. Mr. Kevin Myers made a motion to adopt the proposed agenda with flexibility. Mr. Peter Cook seconded the motion and it carried unanimously.

NUISANCE ISSUE - 3460 SOUTH 1145 EAST LAND TRUST. 3460 S 1145 E, LAGRANGE, INDIANA

Mr. Kurt Bachman, County Attorney, explained that the nuisance hearing today is being continued from November 21, 2022 and is for the nuisance issue for 3460 South 1145 East Land Trust, 3460 S 1145 E, LaGrange, Indiana. Mr. Kurt Bachman, County Attorney, swore in Mr. Bill Stewart, Code Enforcement Officer. Mr. Stewart explained that he visited the property today and it is still a public nuisance issue. Mr. Terry Martin closed the public hearing.
