MARCH 20, 2023

REGULAR SESSION

The LaGrange County Commissioners met in Regular Session on Monday, March 20, 2023, in their meeting room, County Office Building, 114 W. Michigan Street, LaGrange, Indiana, 46761, at 8:30 a.m., with the following present: Commissioners, Mr. Terry A. Martin, Mr. Kevin R. Myers, and Mr. Peter A. Cook; and LaGrange County Auditor, Kathryn Hopper. Mr. Terry Martin, President, called the meeting to order and led in saying the Pledge of Allegiance to the Flag. Mr. Kevin Myers made a motion to adopt the proposed agenda with flexibility. Mr. Peter Cook seconded the motion and it carried unanimously.

EMERGENCY MANAGEMENT AGENCY - PERMISSION TO APPLY FOR GRANT

Mr. Bill Morr, Emergency Management Agency Director, was present. He requested permission to apply for a federal grant, in the amount of up to \$150,000. The grant is a reimbursable grant and would be used to purchase equipment, provide training, and fund conference attendance in 2024. Mr. Kevin Myers made a motion to approve the request. Mr. Peter Cook seconded the motion and it carried unanimously.

STAFF TRAINING DAY

Mrs. Jenny Landez, Human Resources Director, requested permission to hold a staff training day on Tuesday, May 30, 2023. Topics would include active shooter, stop the bleed, and first aid, and would include a staff appreciation lunch. Mr. Peter Cook made a motion to approve the request. Mr. Kevin Myers seconded the motion and it carried unanimously.

MAINTENANCE - REQUEST TO CARPET COUNTY OFFICE BUILDING, FIRST FLOOR

Mr. Gary Mast, Maintenance Director, presented quotes for new flooring for the first floor of the County Office Building. The lowest quote is from Family Value Flooring in the amount of \$25,351.05. Mr. Peter Cook made a motion to approve the flooring. Mr. Kevin Myers seconded the motion and it carried unanimously.
