REGULAR SESSION

The LaGrange County Council met in Regular Session on Monday, April 10, 2023, at their meeting room, County Office Building, 114 W. Michigan Street, LaGrange, Indiana 46761, at 8:30 a.m., with the following present: Council Members, Jeffrey L. Brill, Jeffrey A. Campos, Harold D. Gingerich, Steven E. McKowen, Ryan J. Riegsecker, Michael G. Strawser, and James R. Young; and LaGrange County Auditor, Kathryn Hopper. President, Mr. Mike Strawser brought the meeting to order and led the Pledge of Allegiance to the Flag.

COMMUNITY CORRECTION GRANT APPLICATION

Mr. Brett Hays, Executive Director of the Northeast Indiana Community Corrections, presented a request to apply for a grant for the Community Correction program for 2024. Mr. Hays informed the Council that the grant application is for funding a full-time probation officer and a Drug Court coordinator for LaGrange County. Mr. Hays informed the Council that if approved LaGrange would receive \$149,308.24. Mr. Harold Gingerich made a motion to approve the grant application as presented. Mr. Ryan Riegsecker seconded the motion and it carried unanimously.

PURDUE EXTENSION

Ms. Brittney Gilger, County Extension Director, introduced Jeff Burbrink, Agriculture Educator. She also presented the Purdue Extension Impact Report for 2022.

LOCAL INCOME TAX ALLOCATION TO TOWNSHIPS

Mr. Bill Connelly, Clay Township Trustee, thanked the County Council for the County Local Income Tax allocation for public safety to the Townships in LaGrange County. \$100,000 has been allocated for each township. He suggested that this be increased to \$200,000 for 2024.
