OLD BUSINESS:

A. Master Plan – Date Change

The state approved the new park master plan for the years 2024-2029 instead of 2023-2027. A new resolution has been drafted to reflect this revision. Julia Wolheter moved, and Eric Maginn seconded a motion to repeal Master Plan 2023-2027 Adoption Resolution 2023-09-21-A. Motion carried. Julia Wolheter moved, and Eric Maginn seconded a motion to approve Master Plan 2024-2029 Adoption Resolution 2023-10-19. Board signed new Resolution 2023-10-19 Adopting of 2024-2029 Master Plan. Motion carried.

Feedback for course improvements is very positive and players look forward to new tournament-grade goal baskets. Raised over \$2700 to help fund new goal baskets. Chris Sluyter is getting quotes. Discussion involved ideas to find additional funding.
