REGULAR SESSION

The LaGrange County Commissioners met in Regular Session on Monday, February 5, 2024, in their meeting room, County Office Building, 114 W. Michigan Street, LaGrange, Indiana, 46761, at 8:30 a.m., with the following present: Commissioners, Mr. Peter A. Cook and Mr. Kevin R. Myers; and LaGrange County Auditor, Kathryn Hopper. Mr. Terry A. Martin was absent. Mr. Peter Cook, Vice President, called the meeting to order and led in saying the Pledge of Allegiance to the Flag. Mr. Kevin Myers made a motion to adopt the proposed agenda with flexibility. Mr. Peter Cook seconded the motion and it carried unanimously.

PROPERTY ON 107 WEST SPRING STREET, LAGRANGE, INDIANA

Mr. Kurt Bachman, County Attorney, informed the Commissioners that the property at 107 W. Spring Street has been appraised. He will be working on the sale of the property.

PROPERTY AT 7720 S STATE ROAD 3, LAGRANGE, INDIANA

Mr. Kurt Bachman, County Attorney, inquired if there was interest in selling a lot in South Milford, located at 7720 S State Road 3, LaGrange, Indiana. Mr. Kevin Myers made a motion to proceed with appointing appraisers for the property and proceed with selling the property. Mr. Peter Cook seconded the motion and it carried unanimously.

ORDER DESIGNATING POLLING PLACES FOR THE VARIOUS PRECINCTS IN LAGRANGE COUNTY, INDIANA

Mr. Kurt Bachman, County Attorney, presented the following Order for consideration:

COUNTY OF LAGRANGE ORDER NO. 2024-02-05

AN ORDER DESIGNATING POLLING PLACES FOR THE VARIOUS PRECINCTS IN LAGRANGE COUNTY, INDIANA.

WHEREAS, pursuant to Indiana Code ("IC") 3-11-8-3(b), the county executive must secure for each precinct of the county an accessible facility in which to hold the election;

WHEREAS, pursuant to IC 3-11-8-3.1(a), a county executive must designate the polls for each voting precinct not less than twenty-nine (29) days before an election day;

WHEREAS, pursuant to IC 3-11-8-3.1(b), the designation of a polling place under that code section remains in effect until the location of the polling place is altered by an order of the county executive or county election board under that code chapter;

WHEREAS, pursuant to IC 36-2-2-2, the Board of Commissioners of the County of LaGrange ("Commissioners") is the executive of LaGrange County, Indiana ("County");

WHEREAS, on December 3, 2001, pursuant to IC 3-11-1.5 and County order entitled "Order Establishing Precincts" ("Order"), the Commissioners created various voting precincts in the County and established boundaries therefor;

WHEREAS, on March 5, 2018, the Commissioners most recently adopted a motion ("2018 Order") to order the polling locations for the various precincts;

WHEREAS, the Commissioners desire to consolidate the polling place for the Newbury and VanBuren precincts;

WHEREAS, the Commissioners desire to replace the 2018 Order with this order;

WHEREAS, the Commissioners have secured for each precinct of the County the respective polling places designated in this order; *and*

WHEREAS, pursuant to IC 3-11-8-3.2, a county election board must give notice of the place of voting in each precinct by publication in the manner prescribed by IC 5-3-1.

NOW, THEREFORE, BE IT ORDERED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF LAGRANGE, INDIANA, THAT:

SECTION I -- NAME

The name of this order is the "LaGrange County Polling Places Designation Order."

SECTION II – RECITALS

The foregoing recitals, including all defined terms, are hereby incorporated into, and made a part of, this order and found to be true, accurate, and correct.

SECTION III – POLLING PLACES

- C. Absentee Voters. Citizens who intend to vote by absentee ballot are directed to timely do so at the LaGrange County Courthouse at 105 N. Detroit St. LaGrange, IN 46761.
- D. Findings. The polling places in this order are hereby found to be "accessible facilities" within the meaning for that term provided under IC 3-11-8-1.2.
- E. Publication. The County Election Board is hereby authorized, empowered, and directed to give notice of the polling places in each precinct, as established by this order, by publication in accordance with applicable law.

SECTION IV - MISCELLANEOUS

A. References.

- 1. Except where a specific version or edition is given, reference to another section of this order or to another law, document, fund, department, board, program, public servant, or public office, shall extend and apply to the same, as may be subsequently amended, revised, recodified, renamed, reappointed, or renumbered from time to time.
- 2. Reference in this order to a law, document, fund, department, board, program, public servant, or public office, either generally or by title, without reference to another jurisdiction, shall be construed as though it were preceded or followed, as appropriate, by the words "(of) LaGrange County (Indiana)."
- 3. Should a provision of this order require an act to be done which, by law, an agent or deputy may do instead of the principal, the requirement is satisfied by the performance of the act by an authorized agent or deputy.
- B. Conflicts. No part of this order shall be interpreted to conflict with any local, state, or federal laws, and all reasonable efforts should be made to harmonize the same.
- C. Severability. Should any section or part thereof of this order be declared by a court of competent jurisdiction to be invalid, the decision shall not affect the validity of this order as a whole, nor any other portion thereof, and for this purpose the provisions of this order are hereby declared to be severable.
- D. Promulgation. The Auditor is hereby authorized, empowered, and directed to take all action necessary or proper to authenticate, record, publish, promulgate, and/or otherwise make this order effective.
- E. Codification. This order should be codified in the manner customary for ordinances of the Commissioners.
- F. Effective Date. This order shall take effect immediately upon adoption.

Mr. Peter Cook made a motion to approve the Order. Mr. Kevin Myers seconded the motion and it carried unanimously. Mr. Peter Cook made a motion to waive the requirement for second reading. Mr. Kevin Myers seconded the motion and it carried unanimously.

LAGRANGE COUNTY ARTS COUNCIL

Ms. Mary Woodworth, President of the LaGrange County Arts, was present. The LaGrange County Arts is planning to hold an art show on June 29, 2024 and would like to use the Courthouse lawn and the parking lot at the Justice Center. The event will run from 10:00 a.m. to 4:00 p.m. They will be responsible for the clean-up of the area. Mr. Kevin Myers made a motion to approve the use of the grounds. Mr. Peter Cook seconded the motion and it carried unanimously.

HIGHWAY – PURCHASE OF SERVICE TRUCK

Mr. Peter Cook reported that the Soil and Water Conservation District is requesting a grant match in the amount of \$1,500 for a LARA grant to clear logiams out of the Pigeon River Mr. Peter Cook made a motion to approve the software update. Mr. Kevin Myers seconded the motion and it carried unanimously.

Mrs. Susan Howe, Chief Deputy Clerk, presented a quote from CDW Government for the purchase of 10 ipads to be used with elections and two booths for early voting. Mr. Kevin Myers made a motion to approve the purchase. Mr. Peter Cook seconded the motion and it carried unanimously.
