# MARCH 10, 2025

### **REGULAR SESSION**

The LaGrange County Council met in Regular Session on Monday, March 10, 2025, at their meeting room, County Office Building, 114 W. Michigan Street, LaGrange, Indiana 46761, at 8:30 a.m., with the following present: Council Members, Jeffrey L. Brill, Jeffrey A. Campos, Karen S. Eagleson, Harold D. Gingerich, Ryan J. Riegsecker, and James R. Young; and LaGrange County Auditor, Kathryn Hopper. Mr. Michael G. Strawser was absent. President, Mr. Jim Young brought the meeting to order and led the Pledge of Allegiance to the Flag.

### COUNTY ENGINEER - 2026 ROAD PROJECTS

Mrs. Tharon Morgan, County Engineer, explained that she will be applying for a Community Crossing Grant for a road resurfacing project on County Road 700 S from the Town of Topeka to county Road 1100 E. The engineering estimate for the project is \$5,417,983.44. The grant would fund \$1,500,000 if awarded. The grant match would be \$3,917,983.44.

Mrs. Morgan would like to improve the intersection of County Road 700 South and State Road 3. The estimated cost of the project is \$231,250.

An additional appropriation will be advertised for the April 2025 County Council meeting.

### COMMUNITY CORRECTION GRANT APPLICATION

Mr. Brett Hays, Executive Director of the Northeast Indiana Community Corrections, presented a request to apply for a grant for the Community Correction program for 2026. Mr. Hays informed the Council that the grant application is for funding a full-time probation officer and a Drug Court coordinator for LaGrange County. Mr. Harold Gingerich made a motion to approve the grant application as presented. Mr. Jeff Campos seconded the motion and it carried unanimously.

### LAGRANGE COUNTY COMMUNITY FOUNDATION

Mrs. Kathryn Hopper, County Auditor, informed the Council that the LaGrange County Community Foundation has \$42,919 available to grant in 2025 from the endowment fund. The money can be moved to the endowment portion of the fund, can be left in the fund or a check may be issued for deposit in the Hospital Trust fund. Mr. Harold Gingerich made a motion to have a check issued. Mr. Ryan Riegsecker seconded the motion and it carried unanimously.
