LEGAL CLAIMS


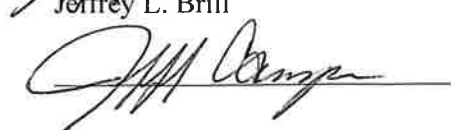

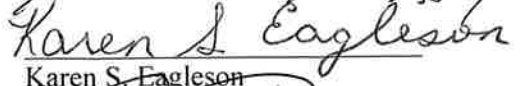

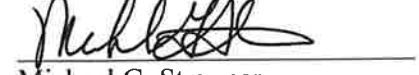
