REGULAR SESSION

The LaGrange County Council met in Regular Session on Monday, May 9, 2016 at their meeting room, County Office Building, 114 W. Michigan Street, LaGrange, Indiana 46761, at 8:30 a.m., with the following present: Council Members, Charles F. Ashcraft, George Bachman, Peter Cook, Harold Gingerich, Steven E. McKowen, Michael G. Strawser and Benjamin Taylor and LaGrange County Auditor, Kay M. Myers. Mr. Peter Cook brought the meeting to order and lead the reciting of the Pledge of Allegiance to the Flag.

JAIL ROOF

Mr. Jeff Campos, County Sheriff, presented two quotes for replacing the jail roof. He stated that a third quote is for a repair of the roof. Mr. Mike Strawser made a motion to approve the quote for Shetler Roofing for \$105,000. Mr. George Bachman seconded the motion and it carried unanimously.

SPECIAL LOIT DISTRIBUTION

Mrs. Kay Myers, County Auditor, informed the Council there is \$886,018.03 from the special LOIT distribution can put in to fund 1229 LOIT Special Distribution which is restricted to only highway type items or it can be put in general fund, rainy day or a home rule fund. Auditor Myers explained Fund 1229 which has received \$2,658,054.11 is used exclusively for infrastructure. Mr. Charles Ashcraft made a motion to put the 25% (\$886,018.03) in the rainy day fund. Mr. George Bachman seconded the motion. Mr. Harold Gingerich amended motion to pay the jail roof from rainy day. Mr. George Bachman seconded the amendment and it carried unanimously. Original motion was passed.

LANDFILL LETTER OF CREDIT

Mr. Kurt Bachman, County Attorney, request Council consider utilizing major moves funds to establish a trust that will allow the County to eliminate the letter of credit for the land fill closure. Mr. George Bachman made a motion to advertise an additional appropriation of \$1,031,424.00 from major moves and set joint session on 6/13. Mr. Harold Gingerich seconded the motion and it carried unanimously.

INVETIGATOR AGREEMENT

Mr. Steve McKowen made a motion to approve the agreement. Mr. Ben Taylor seconded the motion and it carried unanimously. Mr. Mike Strawser made a motion to waive second reading. Mr. Harold Gingerich seconded the motion and it carried unanimously.
