ADDITIONAL TAX - WHEEL TAX, SURTAX, LOIT

County Attorney Kurt Bachman, Jeff Peters and Pam Coleman presented information on income tax options to the Council. Mr. Peters informed the board October 31 is the deadline for implementation for the money to be available in 2017. Ms. Coleman presented information for the 2015 surtax and wheel tax monies along with options for increasing the Surtax / wheel tax rates. There was much discussion. The Council request County Attorney Kurt Bachman & Mr. Peters's office work toward a public hearing for a LOIT rate implementation at the August meeting.
