The LaGrange County Council met in Regular Session on Monday, March 9, 2020, at their meeting room, County Office Building, 114 W. COMPREHENSIVE PLAN

Ms. Octavia Yoder, LaGrange County Community Foundation Executive Director, explained that the LaGrange County Community Foundation (LCCF) would like to support a new county-wide comprehensive plan and will contribute \$100,000 toward the project, through the Lilly Endowment initiative. The last comprehensive plan was completed in 2005 and updated in 2010. Most plans cost between \$150,000 to \$250,000. Region III-a could be the third party to manage the project, for a fee of \$15,000. Ms. Yoder anticipates receiving grants in the amount of \$20,000, and other funding in the amount of \$20,000.
