REGULAR SESSION

The LaGrange County Council met in Regular Session on Monday, May 11, 2020, at their meeting room, County Office Building, 114 W. Michigan Street, LaGrange, Indiana 46761, at 8:30 a.m., with the following present: Council Members, Jeffrey L. Brill, Harold D. Gingerich, Steven E. McKowen and Michael G. Strawser; and LaGrange County Auditor, Kathryn Hopper. Charles F. Ashcraft, Peter A. Cook and Ryan J. Riegsecker and were available by remote. Mr. Mike Strawser brought the meeting to order and led the Pledge of Allegiance to the Flag.

PETERS MUNICIPAL CONSULTANTS, LTD

Mr. Jeffrey Peters, Peters Municipal Consultants, LTD, the County's financial advisor was available remotely. He gave an update on the financial status of the County. He reported that the County has excellent cash reserves to withstand a temporary downturn in the economy. The Motor Vehicle Highway and Local Road and Street Funds are expected to be the most drastically impacted in 2020 due to decreased gas tax. However, both funds appear to have adequate cash reserves to withstand the assumed 2020 shortfall.

LAGRANGE COUNTY COMMUNITY FOUNDATION

Mrs. Kathryn Hopper, County Auditor, informed the Council that the LaGrange County Community Foundation has \$38,012 available to grant in 2020 from the endowment fund. The money can be moved to the endowment portion of the fund, can be left in the fund or a check may be issued for deposit in the Hospital Trust fund. Mr. Harold Gingerich made a motion to have a check issued. Mr. Jeff Brill seconded the motion and it carried unanimously.
