REGULAR SESSION

The LaGrange County Commissioners met in Regular Session on Monday, April 20, 2015, in their meeting room, County Office Building, 114 W. Michigan Street, LaGrange, Indiana, 46761, at 8:30 a.m., with the following present: Commissioners, John A. (Jac) Price, Larry Miller, Terry Martin; and LaGrange County Auditor, Kay M. Myers. Mr. Jac Price, President, called the meeting to order and led those present in saying the Pledge of Allegiance to the Flag. Mr. Larry Miller made a motion to adopt the proposed agenda with flexibility. Mr. Terry Martin seconded the motion and it carried unanimously.

COMMUNITY CORRECTION PROGRAM

Mr. Brett Hays presented an update on the Community Corrections program and the Home Detention program. There was much discussion between the Commissioners and Mr. Hays.

VEHICLE USE AGREEMENT

Mr. Kurt Bachman, County Attorney, presented request for Mr. Jason Boggs, Building Commissioner, to use a take home vehicle. Mr. Larry Miller made a motion to approve the request. Mr. Terry Martin seconded the motion and it carried unanimously.

INDEPENDANT CONTRACT AGREEMENT

Mr. Kurt Bachman, County Attorney, informed the Commissioners that the Independent Contractor agreement is ready for Mr. Thomas Marks, although it has not been reviewed by the Auditor, Building Commissioner, or Human Resources Director. The Contract is for May 4, 2015 thru August 28, 2015 for doing work for the Building Department. Mr. Bachman reviewed the terms with the Commissioners. Mr. Larry Miller made a motion to approve, subject to review and approval by the Auditor, Building Commissioner, and Human Resources Director with the Commissioners signing. Mr. Terry Martin seconded the motion and it carried unanimously.

COUNCIL ON AGING (COA) GRANT HEARING

Mr. Kurt Bachman, County Attorney, informed the Commissioner there are several documents for the hearing being held today for the Council on Aging Public Facilities Program Grant that require Commissioner approval and signature. Mr. Larry Miller made a motion to approve and authorize the President to sign the authorization letter, citizen participation report, a language access plan and section 106 preservation letter. Mr. Terry Martin seconded the motion and it carried unanimously.

COMMON CONSTRUCTION WAGE COMMITTEE - TOWN OF SHIPSHEWANA

Mr. Terry Martin seconded the motion and it carried unanimously.
