REGULAR SESSION

The LaGrange County Commissioners met in Regular Session on Monday, June 6, 2016, in their meeting room, County Office Building, 114 W. Michigan Street, LaGrange, Indiana, 46761, at 8:30 a.m., with the following present: Commissioners, Larry Miller, Terry Martin, Kevin Myers; and LaGrange County Auditor, Kay M. Myers. President Larry Miller called the meeting to order and led those present in saying the Pledge of Allegiance to the Flag. Mr. Terry Martin made a motion to adopt the proposed agenda with flexibility. Mr. Kevin Myers seconded the motion and it carried unanimously.

BRIDGE #68

Mr. Kurt Bachman, County Attorney, presented a notice to proceed to Butler, Fairman, and Seufert, Inc for bridge #68 and request commissioners sign. Mr. Terry Martin made a motion to approve motion to proceed for bridge #68. Mr. Kevin Myers seconded the motion and it carried unanimously.

USI – ASSET MANAGEMENT CONTRACT

Mr. Kurt Bachman, County Attorney, informed the Commissioners Highway Superintendent Randy VanWagner is request to use USI for the asset management plan. Attorney Bachman stated the contract will need modified and requesting the Commissioner's approve and authorize to sign outside of a public meeting. Mr. Terry Martin made a motion to approve the asset management plan for \$5,000.00 and authorize signing outside of a public meeting. Mr. Kevin Myers seconded the motion and it carried.

JUSTICE CENTER PHASE 2

SPEED LIMIT

Mr. Kurt Bachman, County Attorney, informed Commissioners there is a request change to the speed limit on 500 E from 100 S to 200 S from the default of 55mph. The Engineering and Traffic Investigation Committee, made up of President Council, President Commissioners, Highway Superintendent, Sheriff and Engineer will need to make a determination there is a safer speed. There was discussion regarding the County's lack of an Engineer. The Commissioners request the sheriff department collect data then determine meeting date.

LARE GRANT

Mr. Martin Franke, Soil and Water Conservation District Manager informed the Commissioners they have received a \$6,000.00 thru the Lake and River Enhancement grant. The grant money is used to remove log jams on the river. They are requesting Commissioners contribute \$1000.00 to the project. Mr. Kevin Myers made a motion to approve \$1000.00 from riverboat. Mr. Terry Martin seconded the motion and it carried unanimously.
