AUGUST 1, 2016

REGULAR SESSION

The LaGrange County Commissioners met in Regular Session on Monday, August 1, 2016, in their meeting room, County Office Building, 114 W. Michigan Street, LaGrange, Indiana, 46761, at 8:30 a.m., with the following present: Commissioners, Larry N. Miller, Terry A. Martin, Kevin R. Myers; and LaGrange County Auditor, Kay M. Myers. President Larry Miller called the meeting to order and led those present in saying the Pledge of Allegiance to the Flag. Mr. Terry Martin made a motion to adopt the proposed agenda with flexibility. Mr. Kevin Myers seconded the motion and it carried unanimously.

CIRCUIT COURT SPACE NEEDS

Judge VanDerBeck, Circuit Court Judge, informed the Commissioners, through the Community Corrections Grant, they have another full time employee starting today. there is no additional room in the courthouse and there is concern when absentee voting takes place and where that will take place.

ADDICTIONS RECOVERY CENTERS, INC - SERVICE AGREEMENT

Mr. Kurt Bachman, County Attorney, presented an agreement between LaGrange County Superior Court and Addiction Recovery Centers, Inc. and explained that it is ready for approval retroactive May 1, 2016. Mr. Terry Martin made a motion to approve the agreement retroactive to May 1. Mr. Kevin Myers seconded the motion and it carried unanimously.

INFRACTION DEFERAL

Mr. Kurt Bachman, County Attorney, presented a license agreement with Travis Glick to run the Deferral program retroactive to June 27, 2016. Mr. Terry Martin made a motion to approve the agreement retroactive to June 27. Mr. Kevin Myers seconded the motion and it carried unanimously.

BUCK LAKE ROAD

Ms. Joy Sharp presented a request that trees be removed in the easement, known on the deed as Buck Lake Road. This prohibits use of the easement. Mr. Terry Martin made a motion to have the County Highway remove the trees planted in the right of way, have the surveyor stake the property and advise the current homeowner of the actions being taken. Mr. Kevin Myers seconded the motion and it carried unanimously.

SHERIFF'S DEPARTMENT FUNRAISER

Mr. Jeff Campos, County Sheriff, requested approval to do a fundraiser motorcycle ride throughout LaGrange County to benefit the Sheriff's honor guard and canine unit. Mr. Terry Martin made a motion to approve the fundraiser. Mr. Kevin Myers seconded the motion and it carried unanimously.

MAINTENANCE

Mr. Gary Mast presented two quotes to replace the roof at the Health Department. Mr. Kevin Myers made a motion to accept the quote from D & L Metal Sales, in the amount of \$26,322.00. Mr. Terry Martin seconded the motion and it carried unanimously.

McCANN NUISANCE HEARING

The LaGrange County Nuisance Enforcement Officer, William Donald ("Don") Wismer, was sworn in prior to providing testimony. Mr. Wismer presented evidence regarding a nuisance matter at 0645 E 600 N, Howe, Indiana. owned by Mr. Justin McCann. Mr. Terry Martin made a motion to affirm the order and install the fine of \$300.00 per week, beginning May 23, 2016, until the nuisance is abated. Mr. Kevin Myers seconded the motion and it carried unanimously.

COUNTY ROAD 200 NORTH

Mr. Rex Pranger, County Surveyor, requested approval to use the ground up road in the base on the west side of the project. the change will increase the longevity of the road. Estimated cost of the change will be \$60,000.00. Mr. Terry Martin made a motion to approve the change. Mr. Kevin Myers seconded the motion and it carried unanimously.

<u>SHERIFF DEPARTMENT – SIMULCAST</u>

Mr. Jeff Campos, County Sheriff, informed the Commissioners the change from wide banding to narrow banding has negatively affected the local fire departments and is limiting the number of firemen responding. Mr. Kent Koselke and Mr. Randy Fisher, Emergency Radio Service, explained the simulcast would allow a dispatch to go out to all departments with one page verses five individual pages. The cost for the package is \$840,960.61. Mr. Terry Martin made a motion to pass on to Council with a positive recommendation. Mr. Kevin Myers seconded the motion and it carried unanimously.
