### MAY 1, 2017

#### REGULAR SESSION

The LaGrange County Commissioners met in Regular Session on Monday, May 1, 2017, in their meeting room, County Office Building, 114 W. Michigan Street, LaGrange, Indiana, 46761, at 8:30 a.m., with the following present: Commissioners, Mr. Larry N. Miller, Mr. Terry A. Martin, and Mr. Dennis H. Kratz; and LaGrange County Chief Deputy Auditor, Kathy Hopper. Mr. Larry Miller, President, called the meeting to order and led those present in saying the Pledge of Allegiance to the Flag. Mr. Terry Martin made a motion to adopt the proposed agenda with flexibility. Mr. Dennis Kratz seconded the motion and it carried unanimously.

### BRIDGE NO. 47 - COUNTY ROAD 700 SOUTH OVER NORTH BRANCH ELKHART RIVER

Ms. Sarah Farlow, County Engineer, reported that she has reviewed the Bids for Bridge No. 47 and recommends that the bid be awarded to JCI Bridge Group, Inc. for \$229,888.90. Mr. Terry Martin made a motion award the bid to JCI Bridge Group, Inc. Mr. Dennis Kratz seconded the motion and it carried unanimously.

### STATE ROAD 120 - ROAD CLOSURE FOR INDIAN SUMMER DAYS

Mr. Kurt Bachman, County Attorney, requested permission to apply to INDOT to close a portion of State Road 120 in Howe on September 15 and 16, 2017 for Indiana Summer Days. Mr. Terry Martin made a motion to approve. Mr. Dennis Kratz seconded the motion and it carried unanimously.

Mr. Larry Miller presented an additional quote for \$1,450.00 from Kennedy Painting to have the barn painted on the Lambright. AMENDMENT NO. 2017-05-01 A TO THE ZONING ORDINANCE

AN ORDINANCE AMENDING THE ZONING ORDINANCE PASSED AND ADOPTED BY THE BOARD OF COUNTY COMMISSIONERS OF LAGRANGE COUNTY, INDIANA ON THE 17<sup>TH</sup> DAY OF NOVEMBER, 2005, AS AMENDED, FOR THE PURPOSE OF CHANGING THE ZONING CLASSIFICATION AND USES PERMITTED ON REAL ESTATE DESCRIBED IN THIS ORDINANCE FROM AN A-1 DISTRICT TO AN B-3 DISTRICT.

BE IT ORDAINED by the LaGrange County Commissioners, LaGrange, Indiana, that the Zoning Ordinance passed and adopted by the Board of Commissioners of LaGrange County, Indiana, on the 17<sup>th</sup> day of November, 2005, as amended, be hereby and further amended as follows:

1. That the zoning map for the following described real estate located 1,100 feet West of 9420 W US 20, Shipshewana, IN,(parcel # 44-05-21-100-009.000-014) more fully described below hereto, be rezoned and changed from a A-1 District to an B-3 District.

AN ORDINANCE AMENDING THE ZONING ORDINANCE PASSED AND ADOPTED BY THE BOARD OF COUNTY COMMISSIONERS OF LAGRANGE COUNTY, INDIANA ON THE  $17^{\rm TH}$  DAY OF NOVEMBER, 2005, AS AMENDED, FOR THE PURPOSE OF CHANGING THE ZONING CLASSIFICATION AND USES PERMITTED ON REAL ESTATE DESCRIBED IN THIS ORDINANCE FROM AN B-3 DISTRICT TO AN I-2 DISTRICT.

BE IT ORDAINED by the LaGrange County Commissioners, LaGrange, Indiana, that the Zoning Ordinance passed and adopted by the Board of Commissioners of LaGrange County, Indiana, on the 17<sup>th</sup> day of November, 2005, as amended, be hereby and further amended as follows:

1. That the zoning map for the following described real estate located directly North of 7060 N SR 9, Howe, IN,(parcel # 44-03-13-400-009.000-012) more fully described below hereto, be rezoned and changed from a B-3 District to an I-2 District.
