REGULAR SESSION

The LaGrange County Commissioners met in Regular Session on Monday, May 15, 2017, in their meeting room, County Office Building, 114 W. Michigan Street, LaGrange, Indiana, 46761, at 8:30 a.m., with the following present: Commissioners, Mr. Larry N. Miller, Mr. Terry A. Martin, and Mr. Dennis H. Kratz; and LaGrange County Auditor, Kay Myers. Mr. Larry Miller, President, called the meeting to order and led those present in saying the Pledge of Allegiance to the Flag. Mr. Terry Martin made a motion to adopt the proposed agenda with flexibility. Mr. Dennis Kratz seconded the motion and it carried unanimously.

STATE ROAD 120 - ROAD CLOSURE FOR INDIAN SUMMER DAYS

Mr. Kurt Bachman, County Attorney, presented an application to the Indiana Department of Transportation to close a portion of State Road 120 in Howe on September 15 and 16, 2017 for Indiana Summer Days.
