REGULAR SESSION

The LaGrange County Commissioners met in Regular Session on Tuesday, January 16, 2018, in their meeting room, County Office Building, 114 W. Michigan Street, LaGrange, Indiana, 46761, at 8:30 a.m., with the following present: Commissioners, Mr. Larry N. Miller, Mr. Terry A. Martin, and Mr. Dennis H. Kratz; and LaGrange County Auditor, Kay M. Myers. Mr. Larry Miller, President, called the meeting to order and led those present in saying the Pledge of Allegiance to the Flag. Mr. Terry Martin made a motion to adopt the proposed agenda with flexibility. Mr. Dennis Kratz seconded the motion and it carried unanimously.

JUVENILE DETENTION ALTERNATIVES INITIATIVE

Mr. Randy Merrifield, Juvenile Detention Alternatives Initiative Coordinator, would like permission to apply for the grant for July 1, 2018 to June 30, 2019. The coordinator's salary has been \$50,000 and the new grant will not fund that. Judge VanDerbeck has said he would fund \$10,000 for the position out of the Rogers Home Income Fund. Mr. Terry Martin made a motion to send a positive recommendation to the County Council. Mr. Dennis Kratz seconded the motion and it carried unanimously.

PRENTISS CEMETERY

Mr. Kurt Bachman, County Attorney, reported that the Prentiss Cemetery deed is ready for signature.

Mr. Dennis Kratz made a motion to sign the deed transferring the Prentiss Cemetery to Springfield Township. Mr. Terry Martin seconded the motion and it carried unanimously.
