### MARCH 19, 2018

#### **REGULAR SESSION**

The LaGrange County Commissioners met in Regular Session on Monday, March 19, 2018, in their meeting room, County Office Building, 114 W. Michigan Street, LaGrange, Indiana, 46761, at 8:30 a.m., with the following present: Commissioners, Mr. Larry N. Miller, Mr. Terry A. Martin, and Mr. Dennis H. Kratz; and LaGrange County Auditor, Kay M. Myers. Mr. Larry Miller, President, called the meeting to order and led those present in saying the Pledge of Allegiance to the Flag. Mr. Terry Martin made a motion to adopt the proposed agenda with flexibility. Mr. Dennis Kratz seconded the motion and it carried unanimously.

### PAYGOV.US, LLC

Mr. Kurt Bachman, County Attorney, presented an agreement with PayGOV.US LLC for a payment processing system for LaGrange County. Mr. Terry Martin made a motion to approve the agreement and have the President sign. Mr. Dennis Kratz seconded the motion and it carried unanimously.

### JAIL BUILDING CORP.

Mr. Kurt Bachman, County Attorney, inquired if the Commissioners would like to reappoint the following Jail Building Corp. members: Tracy Harker, Kevin Myers and Mike Strawser. Mr. Terry Martin made a motion to reappoint the current Jail Building Corp members and set a meeting for April 2, 2018. Mr. Dennis Kratz seconded the motion and it carried unanimously.

### **DEMOLITION SERVICES AGREEMENT**

Mr. Kurt Bachman, County Attorney, presented a Demolition Services Agreement with Shetler Construction, LLC for the demolition and cleanup of a barn located on the Lambright Farm property. Mr. Terry Martin made a motion to approve the agreement. Mr. Dennis Kratz seconded the motion and it carried unanimously.

### INTERLOCAL COOPERATION AGREEMENT – TOWN OF TOPEKA

Mr. Kurt Bachman, County Attorney, presented an Interlocal Cooperation Agreement between the Town of Topeka and the LaGrange County Drainage Board. The Town of Topeka has a need to rehabilitate and cover an exposed drainage tile on the Barr Tile in the Town. Mr. Dennis Kratz made a motion to approve the agreement. Mr. Terry Martin seconded the motion and it carried unanimously.

#### THE MASTERS TOUCH CONTRACT – FORM 11

Mr. Kurt Bachman, County Attorney, informed the Commissioners his office has reviewed the contract with The Masters Touch for the Form 11's. Mr. Terry Martin made a motion to accept the contract with Masters Touch LLC and have the President sign. Mr. Dennis Kratz seconded the motion and it carried unanimously.

# **BOOTH PROPERTY**

The County purchased land from Mr. William Print Booth's father years ago and Mr. Print Booth would like to buy the property back from the County. Mr. Dennis Kratz made a motion not to see the right of way back to the property owner. Mr. Terry Martin seconded the motion and it carried unanimously.

# **COMMUNITY CORRECTIONS GRANT APPLICATION**

Mr. Brett Hays, Executive Director of Northeast Indiana Community Corrections, presented the TANF grant, which is a regional grant between LaGrange and Steuben counties. There is no cost to LaGrange County for these programs, and that Steuben County will act as the fiscal agent, and that Steuben County will then get reimbursed by the state. The grant is for \$791,437.50 and it is for one year, with the ability to re-apply for the grant every year. Mr. Terry Martin made a motion to approve the grant and have the President sign it. Mr. Dennis Kratz seconded the motion and it carried unanimously.

# **COUNTY JUSTICE BUILDING**

Ms. Sarah Farlow, County Engineer, reported that the Technical Review Committee met on March 16, 2018 to review phase 1 of the County Justice Building project. Mr. Terry Martin made a motion to approve phase 1 and authorize the documents to be signed outside of a public meeting by the President. Mr. Dennis Kratz seconded the motion and it carried unanimously.

# **HIGHWAY - EQUIPMENT PURCHASE**

Mr. Randy VanWagner, Highway Superintendent, presented a quote for 2 snow plows for the new trucks. The quote is from W. A. Jones in the amount of \$7,927.00 each. Mr. Dennis Kratz made a motion to approve 2 snow plows. Mr. Terry Martin seconded the motion and it carried unanimously.

### **HIGHWAY - ROOF**

Mr. Randy VanWagner, Highway Superintendent, presented a quote from Shetler Construction, LLC for a foam and coatings system on the metal roof at the Highway office, in the amount of \$9,322.00.
