REGULAR SESSION

The LaGrange County Commissioners met in Regular Session on Tuesday, September 3, 2019, in their meeting room, County Office Building, 114 W. Michigan Street, LaGrange, Indiana, 46761, at 8:30 a.m., with the following present: Commissioners, Mr. Larry N. Miller and Mr. Dennis H. Kratz; and LaGrange County Auditor, Kathryn Hopper. Mr. Terry A. Martin was absent. Mr. Larry Miller, President, called the meeting to order and led in saying the Pledge of Allegiance to the Flag. Mr. Dennis Kratz made a motion to adopt the proposed agenda with flexibility. Mr. Larry Miller seconded the motion and it carried unanimously.

CLERK VOTING MACHINES

Mrs. Bonnie Brown, County Clerk, explained that White County would like to use 20 of our voting machines for an election this year. Microvote will provide a \$1,000 credit to LaGrange County on next year's election service fees. Microvote will take full responsibility for any damage that may occur to the machines. Mr. Dennis Kratz made a motion to approve the use of the machines. Mr. Larry Miller seconded the motion and it carried unanimously.

RODRIGUEZ SETTLEMENT

Mr. Kurt Bachman, County Attorney, reported that the Julie Rodriguez versus LaGrange County case is ready to be settled. Mr. Dennis Kratz made a motion to approve the settlement and sign the documents outside of a public meeting. Mr. Larry Miller seconded the motion and it carried unanimously.

SATELLITE TRACKING OF PEOPLE, LLC

Mr. Kurt Bachman, County Attorney, explained that the County has an agreement with Satellite Tracking of People, LLC, for services associated with work release. The Sheriff would like to switch to another company for these services

Mr. Dennis Kratz made a motion authorize the County Attorney to work with the Sheriff for the transition to the new company. Larry Miller seconded the motion and it carried unanimously.

COUNCIL ON AGING - PARKING LOT

Mrs. Cheri Perkins, Council on Aging Executive Director, explained that the parking lot at the Council on Aging facility is in need of asphalt. She has a quote from B & J Construction in the amount of \$69,800.00. The Cole Foundation has granted \$25,000 towards the project. Mr. Dennis Kratz made a motion to approve \$44,800.00 out of the Cumulative Capital Development fund for the project. Mr. Larry Miller seconded the motion and it carried unanimously.

PLAN COMMISSION - VEHICLE REQUEST

Mrs. Robbie Miller, Planning Administrator, presented quotes for a vehicle for the Plan Commission department. The lowest quote is a 2019 Dodge Durango from Shepherd's in the amount of \$27,420.00. Mr. Dennis Kratz made a motion to approve the request, less the trade in of the current vehicle and to pay for the vehicle out of the Cumulative Capital Development fund. Mr. Larry Miller seconded the motion and it carried unanimously.

AN ORDINANCE AMENDING THE ZONING ORDINANCE PASSED AND ADOPTED BY THE BOARD OF COUNTY COMMISSIONERS OF LAGRANGE COUNTY, INDIANA ON THE 17TH DAY OF NOVEMBER, 2005, AS AMENDED, FOR THE PURPOSE OF CHANGING THE ZONING CLASSIFICATION AND USES

PERMITTED ON REAL ESTATE DESCRIBED IN THIS ORDINANCE FROM A S-1 DISTRICT TO AN A-1 DISTRICT.

BE IT ORDAINED by the LaGrange County Commissioners, LaGrange, Indiana, that the Zoning Ordinance passed and adopted by the Board of Commissioners of LaGrange County, Indiana, on the 17th day of November, 2005, as amended, be hereby and further amended as follows:

1. That the zoning map for the following described real estate located at parcel #: 57-04-04-100-169.000-012, 57-04-04-100-174.000-012, 57-04-04-100-111.000-012, 57-04-04-100-115.000-012, 57-04-04-100-112.000-012, Wolcottville more fully described below hereto, be rezoned and changed from a S-1 District to an A-1 District.
