CALL TO ORDER: Tyler Young called the meeting to order at 7:07 p.m.

INVITATION FOR PUBLIC COMMENT ON NON-PUBLIC HEARING ITEMS:

ADOPT AGENDA: Lynn Bowen made a motion to adopt the agenda, Freeman Miller seconded the motion. A vote was taken, motion carried.

APPROVE MINUTES OF PREVIOUS MEETING: Lynn Bowen made a motion to approve the previous minutes pending minor corrections, Miriam Carnahan seconded the motion. A vote was taken, motion carried. The previous minutes were approved pending the corrections.

The board discussed the site plan and possible water treatment plans.

Steve Engleking made a motion to approve the site plan subject to any amendments made to the site plan be filed with the Plan Commission office. Freeman Miller seconded the motion. A vote was taken, motion carried.

A vote was taken, 8 Yes / 0 No / 0 Abstain and the motion carried.

Zach Holsinger shared his concerns in regards to the proposed driveway. Tyler Young stated the Board of Zoning appeals also had many concerns and there was much deliberation before the variance was granted.

Lynn Bowen made a motion to approve the site plan, Freeman Miller seconded the motion. A vote was taken 7 Yes / 1 No / 0 Abstain and the motion carried.

Robbie Miller introduced the petition and informed the board the petition was given a positive recommendation from the Plat Committee.

Jeffrey Schaffer, 3720 Oakridge Drive, Elkhart, was present on behalf of the petitioner and reviewed the site plan. Mr. Schaffer explained the current state of the storm water pond and how the client intended to address the issues.

The board discussed the site plan and previous calls of flooding.

Zach Holsinger suggested a condition to require the pond to be piped to the outlet if the retention pond corrections are not successful.

Steven Engleking made a motion to approve the site plan subject to the occurrence that the proposed drainage plan is ineffectual then the retention pond will be piped to the outlet to the regulated drain. Freeman Miller seconded the motion. A vote was taken 8 Yes / 0 No / 0 Abstain and the motion carried.
