REGULAR SESSION

The LaGrange County Commissioners met in Regular Session on Tuesday, January 18, 2022, in their meeting room, County Office Building, 114 W. Michigan Street, LaGrange, Indiana, 46761, at 8:30 a.m., with the following present: Commissioners, Mr. Terry A. Martin and Mr. Kevin R. Myers, and LaGrange County Auditor, Kathryn Hopper. Mr. Peter Cook was absent. Mr. Terry Martin, President, called the meeting to order and led in saying the Pledge of Allegiance to the Flag. Mr. Kevin Myers made a motion to adopt the proposed agenda with flexibility. Mr. Terry Martin seconded the motion and it carried unanimously.

LAGRANGE COUNTY ECONOMIC DEVELOPMENT COMMISSION - APPOINTMENT

The LaGrange County Council recommended Mr. Peter Cook for appointment to the LaGrange County Economic Development Commission. Mr. Kevin Myers made a motion to appoint Peter Cook to the LaGrange County Economic Development Commission. Mr. Terry Martin seconded the motion and it carried unanimously.

LAGRANGE COUNTY PLAN COMMISSION

Mr. Terry Martin is the Commissioner appointee to the LaGrange County Plan Commission and will not be available to attend some of the upcoming meetings. Mr. Kevin Myers made a motion to appoint Mr. Kevin Myers as a temporary appointee to the Plan Commission. Mr. Terry Martin seconded the motion and it carried unanimously.

BUILDING DEPARTMENT

Mr. Jason Boggs, Building Commission, requested permission to work with the County Attorney, on unauthorized construction in the County. Mr. Kevin Myers made a motion to approve Mr. Boggs to work with the County Attorney on the issue. Mr. Terry Martin seconded the motion and it carried unanimously.

BRIDGE NO. 73 CARRYING COUNTY ROAD 50 E OVER FAWN RIVER

Mrs. Tharon Morgan, County Engineer, presented a change order on Bridge No. 73 in the amount of \$1,021.96. The change order is to adjust final quantities to match field measured quantities. Mr. Kevin Myers made a motion to approve the change order on Bridge No. 73. Mr. Terry Martin seconded the motion and it carried unanimously.

BRIDGE NO. 75 CARRYING COUNTY ROAD 100 E OVER PIGEON RIVER

Mrs. Tharon Morgan, County Engineer, presented a change order on Bridge No. 75 in the amount of \$34,856.25. The change order is to adjust final quantities to match field measured quantities. Mrs. Morgan explained that more concrete was needed than was expected due to incorrect measuring. The County Attorney will review the contract and the change order.

ENGINEER - REQUEST TO APPLY FOR COMMUNITY CROSSING GRANT

Mrs. Tharon Morgan, County Engineer, requested permission to apply for a Community Crossing Grant. The grant match of 25% would come out of Fund 1173 Motor Vehicle Highway-Restricted. Mr. Kevin Myers made a motion to approve grant application and to authorize the President to sign. Mr. Terry Martin seconded the motion and it carried unanimously. Mr. Terry Martin made a motion to authorize Mr. Kevin Myers to sign the financial commitment letters for the application outside of a public meeting. Mr. Kevin Myers seconded the motion and it carried unanimously.

HIGHWAY - PURCHASE OF STREET SWEEPER

Mr. Ben Parish, Highway Superintendent, requested permission to get pricing on a new street sweeper. He has funding in his budget to cover this purchase. Mr. Kevin Myers made a motion to approve. Mr. Terry Martin seconded the motion and it carried unanimously.
