REGULAR SESSION

The LaGrange County Commissioners met in Regular Session on Monday, December 20, 2021, in their meeting room, County Office Building, 114 W. Michigan Street, LaGrange, Indiana, 46761, at 8:30 a.m., with the following present: Commissioners, Mr. Terry Martin and Mr. Kevin R. Myers; LaGrange County Auditor, Kathryn Hopper. Commissioner Mr. Peter A. Cook attend virtually. Mr. Terry Martin, President, called the meeting to order and led in saying the Pledge of Allegiance to the Flag. Mr. Kevin Myers made a motion to adopt the proposed agenda with flexibility. Mr. Peter Cook seconded the motion. Upon roll call vote, the motion carried unanimously.

REQUEST FOR LEAVE OF ABSENCE
