REGULAR SESSION

MARCH 15, 2021

The LaGrange County Commissioners met in Regular Session on Monday, March 15, 2021, in their meeting room, County Office Building, 114 W. Michigan Street, LaGrange, Indiana, 46761, at 8:30 a.m., with the following present: Commissioners, Mr. Terry A. Martin, Mr. Kevin R. Myers, Mr. Peter A. Cook; and LaGrange County Auditor, Kathryn Hopper. Mr. Terry Martin, President, called the meeting to order and led in saying the Pledge of Allegiance to the Flag. Mr. Kevin Myers made a motion to adopt the proposed agenda with flexibility. Mr. Peter Cook seconded the motion and it carried unanimously.

COMMUNITY CONNECTIONS FOR PEOPLE WITH DISABILITIES GRANT

Mr. Kurt Bachman, County Attorney, explained that the Community Connections for People with Disabilities Grant, needs to have the sub recipient agreement signed in front of the County Attorney. Mr. Kevin Myers made a motion to sign the sub recipient agreement and authorize signature outside of a public meeting. Mr. Terry Martin seconded the motion and it carried unanimously.

MAINTENANCE - CARPET FOR ASSESSOR'S OFFICE

Mr. Gary Mast, Maintenance Director, presented three quotes for the purchase of new carpet for the Assessor's office. The lowest quote is from Quality Floor, Topeka, Indiana, in the amount of \$4,268.84. Mr. Kevin Myers made a motion to approve the quote from Quality Floor in the amount of \$4,268.84. Mr. Peter Cook seconded the motion and it carried unanimously.

MAINTENANCE – WINDOW SHADES FOR OFFICES

Mr. Gary Mast, Maintenance Director, presented a quote for the purchase of window shades for offices in the County Justice Building, the Purdue Extension Office, and the County Assessor's office. The quote is from Four Woods Shades and Blinds, Topeka, Indiana, in the amount of \$2,100 for the Justice Building, \$1,150 for the Purdue Extension office, and \$920 for the Assessor's office. Mr. Kevin Myers made a motion to approve the quote in the amount of \$4,170 for the window shades, with \$2,100 being paid out of the Rainy Day fund and \$2,070 being paid out of the EDIT fund. Mr. Peter Cook seconded the motion and it carried unanimously.

EMERGENCY MANAGEMENT AGENCY – MOBILE COMMAND UNIT GRANT EXTENSION

Mr. Bill Morr, Emergency Management Agency Director, explained that the grant for the command vehicle expired in August 2020, and he was awarded an extension to March 31, 2021. There is an issue with the company in getting parts for the vehicle. He would like to extend the grant until August 31, 2021. Mr. Peter Cook made a motion to approve the extension of the grant. Mr. Kevin Myers seconded the motion and it carried unanimously.

HIGHWAY - DIAGNOSTIC SCAN TOOL

Mr. Ben Parish, Highway Superintendent, presented a quote from Snap-On tools for a new Pro-link edge master kit, a diagnostic scan tool. The cost of the tool is \$13,706.50 and with a trade in of the current tool, the cost would be \$3,575. Mr. Peter Cook made a motion to approve the purchase in the amount of \$3,575.00. Mr. Kevin Myers seconded the motion and it carried unanimously.

ACCOUNTS PAYABLE VOUCHERS

Mrs. Kathryn Hopper, County Auditor, presented the Accounts Payable Vouchers. Mr. Kevin Myers made a motion to approve the vouchers. Mr. Peter Cook seconded the motion and it carried unanimously.
