APRIL 12, 2021

REGULAR SESSION

The LaGrange County Council met in Regular Session on Monday, April 12, 2021, at their meeting room, County Office Building, 114 W. Michigan Street, LaGrange, Indiana 46761, at 8:30 a.m., with the following present: Council Members, Charles F. Ashcraft, Jeffrey L. Brill, Harold D. Gingerich, Steven E. McKowen, Ryan J. Riegsecker, Michael G. Strawser and James R. Young; and LaGrange County Auditor, Kathryn Hopper. Mr. Mike Strawser, President, brought the meeting to order and led the Pledge of Allegiance to the Flag.

PURDUE EXTENSION

Mr. Steve Engleking, County Extension Director, introduced Brittany Gilger as the new Extension Educator and Kelsey McMullen as a program assistant.

COUNCIL APPOINTMENTS AND BUDGET ASSIGNMENTS

Mr. Mike Strawser appointed Mr. Jim Young to those appointments and assignments that Mr. Peter Cook had been assigned to.

SHERIFF - FIRE SUPPRESSION SPRINKLERS

Mr. Jeff Campos, County Sheriff, explained that the fire suppression sprinklers are inspected every 20 years. There are 133 sprinklers that need to be replaced. The estimated cost is \$46,892. He is waiting to receive quotes. Mr. Steven McKowen made a motion to fund the purchase out of the Rainy Day fund. Mr. Harold Gingerich seconded the motion and it carried unanimously.

SHERIFF - INTERCOM SYSTEM

Mr. Jeff Campos, County Sheriff, requested approval to purchase a new intercom system for the jail. He has two quotes, with the lowest quote in the amount of \$163,320. The current system is from Stanley Security, and they will upgrade the current system for \$96,590. He can pay this out of the Prisoner Reimbursement fund.

SHERIFF - RADIO SYSTEM

Mr. Jeff Campos, County Sheriff, requested approval to purchase a new radio system in the amount of \$317,643. This matter was tabled until the May 10, 2021 Council Meeting.

DRAINAGE ISSUES

Mr. Zachary Holsinger, County Surveyor, explained that in various areas of the County, there are drainage issues that need to be addressed. The Council discussed various options. Mr. Harold Gingerich made a motion to set up a Storm Water Drain Improvement Fund. Mr. Jim Young seconded the motion and it carried unanimously. The Council requested that the Surveyor put together a plan and present it to them at the May 10, 2021 Council meeting.

Mr. Holsinger explained that in 2019 the Council approved \$200,000, payable over four years to the General Drain Improvement Fund. \$100,000 of that has been received. He will need more funds in order to work on the reconstruction of drain projects. Mr. Steve McKowen made a motion to advertise an additional appropriation of \$500,000 from County General Fund. Mr. Charles Ashcraft second the motion and it carried unanimously.
