OLD BUSINESS:

A. Mike Metz Fen LWCF Project

Great progress is being made on installing boardwalks. The track steer is being used to grade the ground trails to prepare for laying limestone.

B. Delt Pavilion Project

Mary Franke brought the pavilion plans to view and a form to be signed to send to the state for plan approvals. After discussion, it was decided to ask the commissioners for up to \$250,000.00 to cover rising costs of materials and shipping.

C. Drinking Fountains

Mary Franke presented quotes for a variety of different drinking fountains. After discussion, the Board prefers the Global Industrial stainless steel option. There was also discussion to purchase another wall mount water fountain for Dallas Lodge and install at a different height for ADA compliancy.

D. 2023 Budget

Nothing new to share. Budgets are presented to Council on August 8, 2022.

E. Master Plan

Summer is busy, so we haven't had time to work on the new Master Plan. The online survey has had 89 responses to date. Leslie Arnold will have surveys available at the 4H fair this year.

F. Attorney

The Park Board has decided to streamline and use the county attorney services. Mary Franke met with the county attorneys this past week already and shared items with them for advisement.

G. Other – Delt Well

Still no water source available at Delt Church Park as we wait for new well.

IDEM has finally approved a site plan. Hoping to have an update soon. Sanderson's Well Drilling said they would be out to install, as soon as IDEM says go.
