BOARD OF COMMISSIONERS OF THE COUNTY OF LAGRANGE, INDIANA

2023-2 CCMG ROAD RESURFACING PROJECT

Notice is hereby given that LaGrange County, Indiana, by and through its Board of Commissioners, will receive sealed bids for the resurfacing work for 2" surface milling, full-depth pavement patching, placement of new 2" HMA surface asphalt, centerline, edge of road, and off-street parking striping, pavement message markings, other misc. items on County Road 1150/1175 East between US 20 and County Road 500 South, all as described in the Request for Bids ("RFB").

Sealed bids will be received at the Office of the LaGrange County Auditor, LaGrange County Annex Building, 114 West Michigan St., LaGrange, IN until 9:00 a.m. local time on Monday, February 19, 2024 ("Deadline"). Bids will also be received by hand delivery at the beginning of the regular meeting of the Board of Commissioners in the Commissioners' Room of the LaGrange County Annex Building, 114 West Michigan St., LaGrange, Indiana by the Deadline. Bids received after the Deadline will be returned unopened unless an unfair competitive advantage would not result. Each bid that is timely submitted in conformity with the Request for Bids will be opened at such meeting and read aloud. An award is expected to be made at the meeting or later as announced.

Each bid shall be accompanied by an acceptable certified check made payable to LaGrange County or an acceptable bid bond in the amount equal to 10% of the total bid price executed by an incorporated surety company in good standing and qualified to do business in the State of Indiana and whose name appears on the current Treasury Department Circular 570.

A Performance Bond and Payment Bond each in the amount of 100% of the Contract price will be required from the Contractor to whom the work is awarded.

All bids submitted are to be in accordance with the RFB, the terms of which are incorporated by reference and shall control throughout the bid process.
